# Climate Change at El Puerto



## A. OBJETIVE

Establish “El Puerto de Liverpool” strategy for addressing climate change and its effect by developing and applying appropriate mitigation and adaptation measures that will allow us to operate under the vision of a low-carbon economy and with the least possible environmental impact.



## B. SCOPE

Applies to “El Puerto de Liverpool”, as well as any of its affiliates and/or subsidiaries in all its operations, products and services; as well as to all its employees, suppliers, contractors, service providers or any other business partner or entity that has adopted El Puerto philosophy.



## C. RULES

As established in the “El Puerto de Liverpool Footprint” sustainability strategy, under the “Environmental Performance” action line, we work to mitigate our impact on climate change by:

# Climate Change at El Puerto de Liverpool

## 1. REDUCING OUR GREENHOUSE GAS (GHG) EMISSIONS

We are committed to being a net zero company in those GHG emissions that we manage directly, and reducing emissions in our supply chain of purchased goods and products. We also formulate targets that are aligned with our environmental goals, under “El Puerto de Liverpool” sustainability strategy.

## 2. REDUCING THE IMPACT OF OUR OPERATIONS ON CLIMATE CHANGE.

- We work to reduce direct greenhouse gas emissions in all of the organization's processes where this is possible, through projects aligned with our sustainability strategy.
- We are steadily migrating toward lower-impact technologies and seeking out business partners in the energy sector to reduce the greenhouse gas emissions associated with our energy consumption, based on our 2040 environmental goals.
- We plan projects and strategies to lower our indirect GHG emissions by inviting our partners and stakeholders to reduce their own carbon footprints.
- We create strategies for incorporating sustainable and resilient criteria into our construction of new facilities and our vision for real estate expansion.

## 3. INCORPORATING GLOBAL BEST PRACTICES ON CLIMATE CHANGE.

- We strive to align “El Puerto de Liverpool” goals with the Sustainable Development Goals (SDGs) 1 directly related to climate change.
- We are continually improving our climate change performance in harmony with internationally accepted frameworks such as GRI and SASB standards.

## 4. RAISING AWARENESS OF THE IMPACT THAT ACTIONS BY EMPLOYEES INSIDE AND OUTSIDE THE ORGANIZATION CAN HAVE ON CLIMATE CHANGE.

- We publish information and inform employees of the actions they can take to help mitigate this problem through a variety of internal communication media.
- We create spaces for connection, in which employees can discuss any concerns or doubts they may have about climate change and its effects.

## 5. EXTEND MITIGATION EFFORTS TO THE ORGANIZATION'S INDIRECT PROCESSES AND BUSINESS PARTNERS.

- We carry out campaigns for our shoppers in which we share our values, with the intention of bringing about significant changes in their consumption patterns in the medium term.

- We work to offer products with a lower environmental impact, from their sourcing of raw materials and manufacturing to logistics, packaging, useful life and final disposal, through our omnichannel sustainable product alignment strategy.
- We create sustainability courses specifically for our suppliers on product sustainability and eco-design, encouraging them to incorporate these best practices into their day-to-day operations.
- We work with the business partners that supply us with merchandise, internal supply, logistics and services on ways to improve their environmental performance through more efficient operations, including the use of more efficient technologies and sustainable raw materials.

## 6. CLIMATE RISK AND OPPORTUNITY MANAGEMENT

- We identify the impacts that climate change risks and opportunities could have on our business strategy under various climate change scenarios, using internationally accepted methodologies such as the TCFD recommendations.
- We design and develop plans for managing, assessing and estimating the impact of climate-related risks and opportunities on our business strategy under various climate change scenarios, using internationally accepted methodologies such as the IFRS sustainability standards.
- We create programs with the basic goal of developing appropriate mitigation and adaptation measures based on our 2040 environmental goals and international frameworks such as the IFRS sustainability standards.
